

**RECIPROCITY AGREEMENT BETWEEN
THE AUSTRALIAN MATHEMATICAL SOCIETY (AustMS)
AND
THE CZECH MATHEMATICAL SOCIETY (CMS) and THE UNION OF
CZECH MATHEMATICIANS AND PHYSICISTS (JCMF)**

This agreement will run from 1 September 2007, for an initial period of five years, at which point it will be reviewed by both Societies. Unless either Society specifically cancels it at that point, the Agreement will be deemed to have been continued sine die.

For current Czech Mathematical Society Members or JCMF Members:

An individual who is a member of the CMS or the JCMF, and who is not normally resident in Australia, is eligible for Reciprocal Membership of the AustMS.

RECIPROCAL MEMBERSHIP DUES: The annual fee for Reciprocal Members of the AustMS is 50% of the rate for Ordinary Members of AustMS.

[Note: The rate for Ordinary Members of AustMS in 2007 is \$100 (Aust).]

RECIPROCAL MEMBERSHIP PRIVILEGES: AustMS Reciprocal Members receive, at no extra cost, the Australian Mathematical Society Gazette, can purchase all the publications of the Society at the rate for Ordinary Members, and are eligible for all the privileges of Ordinary Members except the right to vote. The Secretary of the CMS will receive one copy of each issue of the Australian Mathematical Society Gazette.

For current Australian Mathematical Society Members:

An individual who is a member of the AustMS, and who is not normally resident in the Czech Republic, is eligible for Reciprocal Membership of the CMS and of the JCMF.

RECIPROCAL MEMBERSHIP DUES: The annual fee for Reciprocal Members of the CMS (respectively, the JCMF) is 50% of the rate for Ordinary Members of CMS (respectively, the JCMF).

[Note: The rate for Ordinary Members of the CMS in 2007 is 80 CZK and for Ordinary Members of the JCMF is 200 CZK.]

RECIPROCAL MEMBERSHIP PRIVILEGES: CMS Reciprocal Members are entitled to the same membership benefits as Ordinary Members, including access to publications at the same rate as ordinary members, and are eligible for all the privileges of Ordinary Members. The Secretary of the AustMS will receive one copy of each issue of the Bulletin of the CMS.




